New and Returning Students Registering for the 2024-2025 School Year

## Enrollment Fees: \$200 per student NON-REFUNDABLE or TRANSFERABLE due at enrollment

\$800 per student **NON-REFUNDABLE or TRANSFERABLE** \$300 due by May 1st or upon Enrolling. \$500 due by August 1, 2024.

For parents' convenience, each semester's tuition may be paid in a lump sum or in I2 monthly installments. ALL accounts will be automatically debited for the tuition amount. No interest will be charged for this deferred payment arrangement. However, <u>A</u> <u>MANDATORY SERVICE FEE OF THIRTY-FIVE DOLLARS (\$35.00) WILL BE ASSESSED FOR EACH INSUFFICIENT DEBIT. ALL PERSONAL</u> <u>BANK</u> <u>FEES WILL ALSO APPLY. THIS POLICY WILL BE STRICTLY ENFORCED.</u> A detailed financial policy is printed in the Student Handbook.

Withdrawal of a student **<u>DOES NOT</u>** release parents from their obligations to the school for the balance of the semester's fees and tuition due, with the exceptions listed below:

- Long-term job loss
- Job Transfer requiring relocation more than 25 miles from school.
- Prolonged medical illness or injury

If any of these apply, parents may petition the VCS Board for postponement or forgiveness of this financial obligation. The Board will consider each petition on a case-by-case basis.
